

Packground

Youth work is recognised as an empowering practice which gives agency to young people, eases access to resources and supports them into achieving milestones to better their lives. Therefore, youth work has a clear connection to human rights: supporting young people to exercise their Civic and Political and Social and Economic rights. However, in some parts of the youth work community of practice there's a tendency to neutralise this connection in contemporary youth work narratives and practices (Ohana, 2020). This has been accelerated by the shrinking of civil spaces for organisations engaged in the youth sector (Deželan et al., 2020). This tendency significantly affects youth people from minority groups and identities in a negative way. In many instances young people from minorities face considerable barriers in accessing youth work services, especially those which are tailored to their specific needs and situations.

🖋 Goal Setting

The aim of this project is to revitalise youth work's task to address minority youth rights by fostering the human-rights-based approach through capacity building of youth workers and youth work organisation.

The objectives of this project are to:

- Train practitioner youth workers, especially those who are in a proximity to minority young people, in specific tools for minority youth empowerment and advocacy;
- Equip youth workers with tools for the redressing and monitoring of human rights of minority youth;
- Increase the inner readiness of youth workers to outreach to minority youth and offer them tailor-made opportunities;
- Build the capacity of organisations with youth work services in order to increase their coverage with minority youth by integrating specific standard operating procedures and building up connections with other actors of civil society and state institutions advocating for minority rights.

Thematically, this project will explore the intersections between youth work and human rights, in the following specific directions:

- 1. Social-economic empowerment;
- 2. Widening the youth civil space;
- 3. Human rights education and awareness-raising;
- 4. Redress, monitoring and advocacy.


Participant profile

The training is built on the needs and requirements of youth workers and youth organisations, therefore, it will gather practitioner youth workers and youth educators - who also have an influential role in their organisation. Participants should be based in the outreaching access area of minority youth, therefore priority will be given to youth workers who work with minority youth, or work in proximity to minority populations.

The training course will be conducted in English language, the partners may choose to have a language interpretation for their country groups, upon communicating with the project coordinators beforehand.

14-17 Jan 2023	Residential seminar on documenting, integrating and promoting procedures to main- stream minority rights to youth work practise in organisations.


Stay

The training course will be held at Grand Noel Hotel in Bakuriani, Georgia. Participants will be sharing rooms with 2-3 other participants, linen and towels are provided by the hotel. Accommodation and meals are covered by the organisers. Please, let us know if you have allergies, idiosincrasies or other dietary restrictions at least 2 weeks in advance. Participants are required to arrive on 6th of November before 18:00 and depart on 14th of November at 10:00. Bakuriani is a winter resort in the mountains, so it can be quite cold in November, please, check the weather forecast and pack accordingly.

In her work as a trainer, she has been facilitating educational processes for various learning groups, inter alia, practitioners and other key stakeholders. In the youth field, she has been mainly working with young people from marginalised communities, specifically with young people from national, ethnic and linguistic minorities, and young refugees and asylum seekers.

Nika BAKHSOLIANI - a human rights educator and trainer, in the directions of combating hate speech, citizen participation and engagement. As a state-reform direction manager, he has developed capacity building tools on youth policy for the local and regional authorities, including a massive open online course on youth policy. As a trainer he has worked with stakeholders from national, regional and local levels, teachers, trainers, youth workers, peer and youth educators.
